The Company has on Monday, July 07, 2025, sent the postal ballot Notice in electronic form in accordance with the relaxation granted by the Ministry of Corporate Affairs (MCA) vide General Circular No. 09/2024 dated September 19, 2024 to its Members whose name(s) appeared on the Register of Members/ list of beneficiaries as on Friday, July 04, 2025 (cut-off date). The said postal ballot Notice contained the procedure for e-Voting by members as required under the Act, Rules and applicable regulations of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

In accordance with the postal ballot Notice dated Monday, July 07, 2025 dispatched to Members by electronic mode on Monday, July 07, 2025 and the 'Advertisement' pursuant to the Rules published on Wednesday, July 09, 2025, the e-Voting commenced at 09:00 am (IST) on Tuesday, July 08, 2025 and ended at 05:00 pm on Wednesday, August 06, 2025. The e-Voting facility was provided by CDSL.
4. The Members holding shares as on Friday, July 04, 2025 i.e. cut-off date, were entitled to vote on the resolution stated in the postal ballot Notice.
